Possible nature of Ethical violations:

- * Conflict of Interest: Any action that may result in a conflict of interest must be fully disclosed. When impartiality and effectiveness cannot be maintained, the activity should be avoilded or discontinued.
- * Disputes about authorship: Proper authorship representation is usually a matter for the involved parties to resolve.
- * Duplicate submission: Duplicate submission is unprofessional and unacceptable. It misuses the resources of all affected journals, including the valuable time of editors, reviewers, and staff.
- * Fabrication of data or results: Any incidence of fabrication shall be considered to be an extremely serious breach of professional conduct. With potentially severe ethical and legal consequences.

Action / Penalty against defaulters :



Institutional Level Procedure for Plagiarism



Objectives of Anti-Plagiarism -

- To inculcate the habit of respecting the academic integrity and discipline.
- To identify any act of dishonesty in academic work constitutes academic misconduct.

The proposed workflow -

- The research scholar should submit the soft copy of the thesis, research papers, projects and minor research project for the plagiarism check to the committee section through a CD or mail.
- Checking shall be done excluding the bibliography, index and references.
- During the initial plagiarism check, the thesis, project, research paper or proposal shall not be added to the data repository.
- The anti-plagiarism report will be generated and mailed back to the student and the concerned head. (Evaluation).
- The thesis can be printed and submitted to the library only if a letter to this effect is issued to the candidate and the head.
- The candidate shall mandatorily produce the anti-plagiarism report as a part of the thesis.
- If the similarity index is > 25% the modified thesis has to be resubmitted following the step no.1 of the process.
- 9. The student can submit the thesis.
- The third chance shall be considered as the final submission failing which the thesis shall not be accepted.


